NOTIFICATION

The Hon'ble Chancellor and the Governor of Rajasthan emphasized for effective implementation of minimum attendance criteria of 75% to appear in the examinations to be followed strictly and this concern was discussed in the Academic Council of the University held 09.03.2015 as an Agenda No. 8/31. Further, the Vice-Chancellors' Coordination committee meeting held on 05.05.2015 under the Chairmanship of the Hon'ble Chancellor and the Governor, Rajasthan, has further directed the Universities to ensure the fulfillment of minimum requirement of 75% attendance of the students to appear in the examination and the same should also be followed at the examination of University. Further, it has been stressed that the teachers should conduct classes regularly as per the time-table.

Therefore, it is hereby notified that :

1. All deans of the constituent and affiliated veterinary colleges of RAJUVAS, Bikaner and Principals of constituent and affiliated AHDP institutes of RAJUVAS shall ascertain that students appearing in any of the examinations (Semester or Annual) should have fulfilled minimum requirement of 75% attendance in the class. Moreover, shortage of attendance of students should be informed to their parents, periodically.
2. All Deans of constituent and affiliated Veterinary colleges and Principals of constituent and affiliated AHDP institute shall also ascertain by frequently random visits of the classes that the teachers are taking classes regularly as per the time-table as prescribed.
3. As decided in the Vice-Chancellors' Coordination meeting held on 05.05.2015 that Hon'ble Vice-Chancellor shall take round of the campus to ascertain the presence of all the teachers in the classes as per the time-table. Therefore, time-table of all classes should be submitted to the Dean/Principals for onward transmission to Hon'ble Vice-Chancellor at the beginning of each session/semester so that Hon'ble Vice-Chancellor is well informed of timings and places of different classes to be held during academic session/semester.

The above guidelines should be strictly adhered to.
