**Conditions of Supply:-**

1. Rates should be quoted for good quality goods showing the various details of specifications.
2. Rates quoted should be F.O.R. Store at Pashu Vighyan Kendra, Lunkarnsar, Bikaner & and inclusive of all taxes.
3. After the tender has been accepted, the rates shall remain valid for the period 31-03-2022. The period can be extended by mutual agreement.
4. No counter proposals or modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the tender is submitted in response to our tender notice, it will be made applicable to acceptance of terms & conditions given by us and no claims will be entertained. In other words, firm intending to give counter proposals should not submit tender at all.
5. Alternative specifications will not be acceptable.
6. Articles should be strictly accordingly to the specifications.
7. Cost of breakages & shortage during transaction would be deducted from the relative bills. No extra cost on such account will be admissible.
8. Tenders received after the prescribed time and date will be summarily rejected.
9. The cover containing the tender should be super scribed with following words for the supply of **Iron Manger with browsing crate** and submitted to this office latest by 11.00 AM of 19-01-2022.
