- III. Terms of Payment: - If successful, the payment will be released only in 02 installments i.e. **40% after 6 months** and **60% after completion of AMC**. No advance payments shall be payable.
- IV. Authorization of Service Partner: In cases where original manufacturer, authorizes its service partners to handle the AMCs, the Service Partners shall have to provide an AUTHORIZATION CERTIFICATE (issued by OEM & with address details of service partner; not just name) that is issued within 6 months from the date of submission, preferably of same FINANCIAL YEAR 2022-23.
