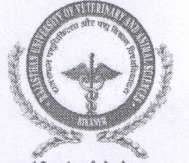

## C I R C U L A R

The classes for 1 Year B.V.Sc. & A.H. are going to commence soon. The Hon'ble Supreme Court of India has shown its serious concern on the incidences of ragging and has issued some strict directives to prevent the menace of ragging. UGC is also very much concerned over this issue and has directed that the **ragging is to be treated as cognizable offence**. The offender may be subjected to:

1. Suspension/Expulsion from the hostel.
2. Rustication from the institution for periods varying from 1-4 semesters.
3. Expulsion from the institute and consequent debarring from admission to any other institution.
4. Fine up to Rs 25,000.
5. Rigorous imprisonment up to three years.

(While the first four types of punishments are to be awarded by the appropriate authority of the institution itself, the last punishment can be awarded only by a court of law.)

Hence all students of AHDP, B.V.Sc. & A.H. as well as of M.V.Sc. & Ph.D. are advised not to indulge in the act of ragging. To avoid such incidences and to curb the evil of ragging in our college campus, area wise 'Anti Ragging Squads' and Institute level Ant ragging committees as per the directives of the Hon'ble Supreme court of India have been formed.

The students are once again advised to avoid indulging in such activities like ragging, which may force the undersigned to take any unpleasant and strict action against them.
