ORDER

In reference to Home(Gr-7)Deptt., Govt. of Rajasthan, Jaipur order No. F.7(1)Home-7/2021 dated 12.08.2021 regarding reopening of colleges/Institutions/Couching Institute following direction guidelines are issue for commencement of classes of B.V.Sc. & A.H., M.V.Sc., Ph.D. and AHDP:-

- The Colleges/Institutes shall plan opening the campuses in phases to carry out the academic activities following necessary protocols/guidelines/directions/advisories issued by the Central/State Governments or competent authorities from time to time, in view of the COVID-19 pandemic.
- 2. The guidelines issued by Government of Rajasthan by vide order No प7(1) गृह- 7/ 2021 विनाँक 12.08.2021 shall be strictly followed by all the colleges /institutes.
- 3. Written consent from the parent is mandatory for those students who are willing to attend the college/institute. For those who do not wish to attend the college/institute, online teaching shall continue.
- 4. The attendance shall not be compulsory but shall remain optional for all the courses.
- 5. All the students shall submit the certificate of completed two doses of COVID-19 vaccination or one completed dose of COVID-19 vaccine and a negative RT PCR test report on the 1st day of arrival to the college and on the 5th day.
- 6. Any student found positive shall be isolated and treated accordingly and such room/ premises shall be closed for 10 days.
- 7. All the students shall strictly follow the COVID appropriate behaviour during their stay at campus and follow **No Mask No Entry**.
- 8. The faculty, staff and students of the college/institute should be encouraged to download 'Aarogya Setu App'.
- 9. The Dean of the respective colleges shall constitute Task teams with earmarked responsibilities to take strategic and immediate actions.
- 10. Theory classes for B.V. Sc & A.H. course and AHDP shall preferably be continued and encouraged ONLINE. However, the students may visit their respective college/institute for consultation of doubts with the faculty members after seeking prior appointment with the concerned teacher, while maintaining physical distancing and other safety protocols.
- 11. Practical classes/ Clinical/Farm practices of BVSc & A.H. degree course for all professional years and AHDP shall be conducted by Offline mode strictly following COVID-19 guidelines.
- 12. It should be ensured that students not more than 50% of the total seating capacity of the classes should be present at any point of time and necessary guidelines/protocols to prevent the spread of COVID-19 are observed.
- 13. For M.V. Sc and Ph.D. courses, theory and practical classes shall be started by physical mode maintaining physical distancing and enforced preventive measures for COVID-19 situation.

- 14. Regular screening of students, faculty and staff should be conducted to avoid the risk of transmission.
- 15. All such programmes and extra curricular activities should be avoided where physical distancing is not possible.
- 16. Unnecessary crowding of students within the campus and at entry/ exit points shall be avoided.
- 17. Classroom benches/chairs shall be sanitized daily. Cleaning and regular disinfection of frequently touched surfaces (door knobs, elevator buttons, hand rails, chairs, benches, washroom fixtures, etc.) to be made mandatory in all class rooms, laboratories, other common areas etc.
- 18. Hostels shall be opened for students as per their accommodation capacity while strictly observing the safety and health preventive measures and guidelines issued from time to time by the competent authority/state/central government.
- 19. The College /Institute may adopt and implement these guidelines by making alterations/ additions/ modifications/ amendments to deal with particular situation(s) in the best interest of students and educational institution/college except in respect of those guidelines that are mandatory
