



## MEMORANDUM OF UNDERSTANDING

### 1.1 THE MEMORANDUM OF UNDERSTANDING:

*This memorandum of understanding is made at Bikaner on this 7<sup>th</sup> day of January, 2020 between Rajasthan Woollen Industries Association, a association duly incorporated under the cooperative Act, 1956 and having its registered office at 104 Industrial area, Rani Bazar, Bikaner 334001 (hereinafter called the First Party which expression shall, unless repugnant to the context or meaning thereof, include its nominees and assigns) on the part;*

AND

*The Rajasthan University of Veterinary and Animal Sciences having its HQs at Bikaner with as assigned jurisdiction of whole of the State of Rajasthan and as established under the Rajasthan University of Veterinary and Animal Sciences Act, 2010 (13<sup>th</sup> of 2010) (hereinafter referred to as RAJUVAS and called the Second Party which expression*

## **1.2 PREAMBLE:**

**1.2.1 WHEREAS** the First Party is engaged in research and development, manufacturing and sale of wool, wool yarn and hand-made carpet. Its area of working is at Bikaner, Beawar, Kekri, Bhilwara, Sikar and Jaipur and involved in improving of livelihood of Sheep farmers & women empowerment. It is also involved in mitigation of environment pollution by utilization of animal waste such as wool waste for manure production and reduction of chemical fertilizers;

**1.2.2 WHEREAS** the First Party is now looking for cooperation from other likeminded companies/ Institutions/organizations/universities etc. working towards similar objectives. The key area of intervention would be research and development for improving sheep animal health, extension services for providing farms solutions to the sheep farmers, resource/people development, new technological intervention in the area of wool production and extension activities for the benefit of sheep farmers;

- 1.2.3 *WHEREAS the Second Party is a renowned University, actively involved in veterinary education, research and extension in all aspects of veterinary and animal sciences (as defined in its Act);*
- 1.2.4 *WHEREAS the First Party hereby represents and make request to the Second Party to join hands in the areas of mutual interests out of the areas mentioned above;*
- 1.2.5 *WHEREAS the Second Party, relying on the representations of the First, has accepted the offer and agreed to join hands in the areas of mutual interests as mentioned above;*
- 1.2.6 *WHEREAS the Second Party has agreed that it will allow use of its research and development facilities, support of its human resource and their technology knowledge, allow promoting joint research, extension services and training programmes to be undertaken under the guidance of the experts as required and / or advised by the Second party etc.;*
- 1.2.7 *WHEREAS the First Party will help in developing/ demonstration of new technologies in the area of research and development for sheep animal health, nutrition, wool and its processing and integrated approach of carpet manufacturing. It will also help in mitigation of environment pollution by utilization of animal waste such as wool waste for manure production;*

1.2.8 *WHEREAS the First Party will join hands in providing extension services and promotional material for farmer education, rural training for entrepreneurship development in the State of Rajasthan. It may also depute its experts to the University for exchange programme for research, extension and human resource development programmes, whenever/ wherever need so felt by both the parties;*

1.2.9 *WHEREAS both the Parties to this M.O.U. agree and acknowledge that the representation made by the Parties herein above are the essence of this arrangement and the parties do hereby undertake to protect the interests of each other (particularly related to the Intellectual Property Rights). But the Second Party shall in no way watch for or promote commercial interest of the First Party;*

1.2.10 *Provided further that, the main purpose of this M.O.U. is to mutually take further the Science and research, and extension of technologies to the sheep farmers/ carpet entrepreneurs;*

### 1.3 MODALITIES OF M.O.U.:

1.3.1 *That the period of M.O.U., initially, will be FIVE years only, which, however, may be further extended till the date so specified, with mutual consent of the parties;*

- 1.3.3 That both the parties, with mutual consent, can add/delete/modify the terms and conditions and statements of this MOU, deemed to be effective from the date of mutual consent;
- 1.3.4 That any party can opt out to terminate this MOU with a month's notice to other party;
- 1.3.5 That any dispute arising out of this MOU shall be mutually tried to be settled, and if no settled mutually, an Arbitrator shall be appointable by mutual consent to settle the dispute.
