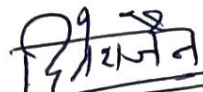

The lumpy Skin Disease (LSD) has affected the livestock very badly not only in the state but nationwide. The disease caused heavy economic loss also. In this scenario the Revolving fund project on cattle feed and mineral mixture plant RAJUVAS has developed one formulation containing amino acid, enzymes various minerals and vitamin, some herbal ingredients along with some other ingredients. Trial has done on the animals suffering from LSD at various Gaushalas, LRS of the University and individual holdings. The feedback received by the farmers, and Gaushala supervisors were very promising. The dose of the formulation is 50 gms morning and evening for 3 to 5 days. The formulation is in powder form and the total cost of treatment is 150 to 250 Rs.
