TERMS & CONDITIONS TO BE FOLLOWED, BEFORE PLACING SUPPLY ORDERS(THE RTPP ACT 2012 AND RULES 2013 SHALL BE APPLICABLE ON THE ALL PROCUREMENT)

- 1. The rate contract is for original manufacturer of Indigenous Instruments & Equipment's, farm tools including spares parts and accessories up to Rs 10.00 Lakh each item excluding GST required for different constituent units of Rajasthan University of Veterinary & Animal Sciences, Bikaner located in Rajasthan State for one year w.e.f. the date of issue of this order.
- 2. Items manufactured indigenously for which proposals from original manufacturer with rates in Indian rupees received are only approved.
- 3. If the rate contract holder quotes/reduces its price to render similar goods at a price lower than the rate contract price to anyone at any time during the currency of the rate contract, the rate contract price, shall be automatically reduced with effect from the date of reducing or quoting lower price, for all delivery of the subject matter of procurement under that rate contract and the rate contract shall be amended accordingly. The firms holding parallel rate contract shall also be given opportunity to reduce price giving them fifteen days time to intimate their acceptance to the revised price. Similarly, if a parallel rate contract holding firm reduces its price shall be conveyed to other parallel rate contract holding firms and the original rate contract holding firm for corresponding reduction in their prices. If any rate contract holding firm does not agree to the reduced price, further transaction with it, shall not be conducted.
- 4. It will be the prerogative of procuring entity whether CMC is to be opted or not . Procuring entity must state this condition clearly in the purchase order to be placed upon the firm.
- 5. The approved manufacturers will submit copy of the above mentioned approved price lists (in 30 copies) to the office of undersigned, submitted with the rate contract proposals
- 6. The supply order will be placed to the original manufacturer by the purchasing authority. In case, original manufacturer appoints its authorized distributors, copy of supply order will be endorsed to authorized distributor as enlisted in Annexure-1. The original manufacturer will produce the bill for making payment of supply or the bill can submit if the original manufacturer authorizes



him for producing bill for each and every supply. Copy of such authorization will be required along with the bill mentioning reference of individual supply order.

- 7. Copy of all the supply orders by purchasing authority/DDOs/Unit Incharge shall invariably be endorsed to Treasury Officer,RAJUVAS, Bikaner failing which the supply order shall be considered invalid and concern Treasury will not process the bill for making its payment.
- 8. University does not guarantee for any quantum of order and liability of any kind.
- 9. This order will remain valid for one year w.e.f. the date of issue of this order.
- 10. The bid security already deposited by successful bidders is converted into performance security.
- 11. Rates:- The Manufacturers have to supply items as per price list submitted by him and no change in the price list in between would be permitted except as mentioned in point no 3 of these terms & conditions.
- 12. Supplier shall owe the sole and complete liability of safe handover of goods to the stores/any other place specified by the consignee after arrival of goods at the campus. Any breakage /loss/damage shall be made by the supplier by replacement of goods. This is mandatory and at the risk and cost of the supplier.
- 13. Delivery:- All the rates are for destination(Free delivery at any place in Rajasthan and inclusive of packing, forwarding, freight and insurance charges). Delivery Period- The Indigenous items should be supplied within 30 days from the date of supply order. Liquidated damages shall be recovered at the prescribed rates, if the firm fails to supply within the supply period provided that the ordering authority on the request of the firm may extend the supply period before its expiry after being satisfied with the reason given by the firm for inordinate delay in supplies. However, extension of supply period may be with or without liquidated damages. In case of extension in the delivery period with liquidated damages recovery shall be made on the basis of the following percentages of value of stores which the tenderer has failed to supply:
 - a. Delay upto one fourth period of the prescribed delivery period- 2.5%
 - b. Delay exceeding one fourth but not exceeding half of the prescribed delivery period- 5%
 - c. Delay exceeding half but not exceeding three fourth of the prescribed delivery period-7.5%
 - d. Delay exceeding three fourth of the prescribed delivery period-10%
- 14. Payment:- Payment against Bill/invoice shall be released only after supply and observance of satisfactory performance. No interest will be payable on the delayed payment for any reason, what so ever.
- 15. Installation: Installation of Indigenous Instruments & Equipment's, farm tools including spares parts and accessories, where ever necessary or demanded shall be done by the firm free of cost, as soon as the above item is supplied.
- 16. Guarantee: Minimum Guarantee period of above item is one year from the date of installation.
- 17. Unit head(s) will verify /adjudge the stock position available before placing any supply order.
- 18. Jurisdiction for legal matter shall be Bikaner.
- 19. Excise duty exemption on purchase of equipment/instruments etc. should be given as per applicability.
- 20. The above terms and conditions shall be followed by the all concerned purchasing authorities/DDOs/Unit Incharge in letter and spirit. For any non-compliance of above terms and conditions, they will be held responsible at their own.



21. Besides above mentioned terms & conditions, the general terms and conditions of RAJUVAS as well as RTPP Act, 2012 and RTPP Rules, 2013 shall be applicable.

Note-This offer can be repudiated at any time in respect of above manufacturers and necessary action can be taken against the during firms by the University. Further rate contract is subject to the production of agreement on NJS of Rs. 500/- duly completed ,signed and attested by public Notary which may be submitted to the office of undersigned within 15 days from the date of issue of this order.
