The main purpose of this Academic Council is to approve the score card as well as qualifications so that the process of recruitments may be geared up.

He also informed the house that Convocation will be organised by RAJUVAS on 25th February, 2021 as permission has been granted by His Excellency Governor of Rajasthan and Chancellor of The University.
