



Minutes of the 16th meeting of the Academic Council held on 7th October, 2020 at 11.00 AM in the Meeting Hall of VC Secretariat, RAJUVAS, Bikaner

The 16th meeting of the Academic Council was held on 7th October 2020 at 11.00 AM in the Meeting Hall of VC Secretariat RAJUVAS, Bikaner under the Chairmanship of Hon'ble Vice-Chancellor Prof. Vishnu Sharma.

The list of Members as well as Invitees present in the meeting has been enclosed as Annexure-1.

At the outset Hon'ble Vice-Chancellor Prof. Vishnu Sharma extended welcome to external members of the Council Dr. Ravindra Sharma, Dr. R.K. Bagherwal and Dr. A.K. Pattnaik as well as newly nominated members of the Council and invitees who were present as well as attended the meeting through online mode.

Hon'ble Vice Chancellor appraised the Council that as per directives of the Raj Bhawan, University prepared and submitted its own Statutes. After evaluated by various departments, the Hon'ble Governor of Rajasthan and Chancellor has assented the Status. Now, these Statutes will be displayed on website and very soon we will get it published for further use. He also made aware the House that RAJUVAS has celebrated decade year on 18th May 2020 in online mode in which Hon'ble Governor and Chancellor was Chief Guest along with Vice Chancellors of various universities, faculty and students. Hon'ble Governor was very pleased to know the initiatives taken by RAJUVAS. The PGIVER, Jaipur has been included in Schedule-I by the Veterinary Council of India. For establishing new Veterinary College at Jodhpur, land has been allotted, civil work will be started and we are hopeful that classes will be started from next academic session.

It was also communicated to the House that ICAR has selected RAJUVAS for establishment of skill development centre at Bikaner and virtual classroom, for which equipment have been provided by ICAR. Online classes are continuing in all the colleges despite of COVID-19 situation. Exams are also being conducted regularly. Final exams will be conducted after guidelines released by VCI in this context. Under the Directorate of HRD, new certificate courses for field veterinarian have been started on payment basis and good response has been receiving from the applicants. Directorate of Extension Education (DEE) initiated a unique programme "RAJUVAS e-Pashupalak Chaupal" through online mode. It will be organised two times in a month and will be broadcasted live on face book page of the University.

It was also apprised the House that RAJUVAS entered in MoU with many national institutes and private organizations. MOU with recognized prestigious institute ILRI is in final stage. University has filed four patents and all of them are on second stage. NABL accreditation of selected laboratories of the university is also in final stage. CAS has been started for the faculty and promotions of Assistant Professors (Grade pay 6000 to 7000 and 7000 to 8000) are over. For rest of the faculty it will be completed very soon. Organic certification of animals and land of LRSs has been procured from authorized agency.

The Hon'ble Vice-Chancellor informed the House that only yesterday, permission for conducting the recruitment on teaching and non-teaching posts has been received from Governor's Secretariat and process has been initiated in this context.

All the members praised the constant efforts of the Hon'ble Vice-Chancellor being undertaken for development and the progress made by RAJUVAS and congratulated.



It was informed by the Registrar to the House that recently the University has conducted RPVT-2020 successfully for which the House appreciated the efforts of team for this achievement.
