

Minutes of the 20th Meeting of the Academic Council held on 21.03.2022 at 11.00 AM in the Meeting Hall of VC Secretariat, RAJUVAS, Bikaner under the chairmanship of Hon'ble Vice-Chancellor Prof. Satish K. Garg

The 20th Meeting of the Academic Council was held on 21.03.2022 at 11.00 AM in the meeting hall of VC Secretariat, RAJUVAS, Bikaner in hybrid mode under the Chairmanship of Hon'ble Vice-Chancellor Prof. Satish K. Garg.

At the outset, Hon'ble Vice-Chancellor, Prof. Satish K. Garg extended warm welcome to all the members of Academic Council particularly external members Prof. Udeyvir Singh, GADVASU, Ludhiana and Dr. Sanjay Sharma, GBPUAT, Pantnagar.

Hon'ble Vice-Chancellor briefed the house about the actions taken on the resolutions of previous meeting held on 30.09.2021 particularly 10% hike in fee of AHD Programme, creation of NRI seats in UG programme and reservation of 15% seats. With regard to Agenda Item No. 19/16 regarding providing Email IDs to all the students of constituent colleges, the Incharge, IUMS explained that necessary information is being sought from the concerned Deans. As soon as the information will be received, desired Email IDs will be provided to them. All the Deans were directed to send the required information in one month's time to IUMS for needful in the matter. It was also directed by the Hon'ble Vice-Chancellor that since the time left for 5th Convocation of RAJUVAS which is scheduled on 29.04.2022, all the Chairmen/Convenors of different committees should finalize their tasks well in time for smooth organization of the Convocation.
