Minutes of the 33rd Meeting of Board of Management

33rd meeting of the Board of Management was held on 06.12.2023 at 10.00 AM in the Conference Hall of VC Secretariat under the Chairmanship of Prof. (Dr.) Satish K. Garg, Hon'ble Vice-Chancellor, RAJUVAS, Bikaner. The list of members who attended this meeting is attached as Annexure 1.

At the outset, Prof. Satish K. Garg, Hon'ble Vice-Chancellor extended warm welcome to all the members of BOM including external members Prof. (Dr.) Col. A.K. Gahlot, Founder and Former VC, RAJUVAS, Bikaner, Prof. Rudra Pratap Pandey, Professor, Deptt. of Surgery, DUVASU, Mathura, Dr. Jagat Bir Phogat, Former Dean, PGS, LUVAS, Hisar, Smt. Krishna Solanki, Women Social Worker, Dr. Amit Nain, VCI Nominee, Sh. Ashok Modi, Industrialist, Sh. Purkha Ram, Progressive Farmer and Dr. S.N. Purohit (Representative of MD, RCDF, Jaipur). He also welcomed Prof. A.P. Singh, Chairman Faculty and Dean, CVAS, Bikaner, Prof. R.K. Dhuria, Director Extension Education, RAJUVAS, Mrs. Bindu Khatri, Registrar as members of the Board and Prof. Hemant Dadhich, Pro Vice-Chancellor, RAJUVAS, Bikaner and Sh. B.L. Sarwa, Comptroller of the University as special invitees.

The House paid homage to Late Shri Gurmeet Singh Ji Koonar, Hon'ble Member of BOM, who untimely passed away on 15.11.2023. The House mourned his sad demise with two minutes of silence.

However, result of the same shall not be declared without the leave of Hon'ble High Court.</p> <p>In reference to aforesaid directions of Hon'ble High Court, the Principal Secretary to Hon'ble Governor vide communication No. 4898 dated 12.09.2023 directed to stop the process of recruitment till further order.</p> <p>Hon'ble Vice-Chancellor also appraised the House that Hon'ble High Court, Jodhpur its vide order dated 06.11.2023 modified the interim order dated 24.08.2023 with the direction that the Respondent Nos. 2 and 3, State of Rajasthan through Principal Secretary, Animal Husbandry Department, Government of Rajasthan, Secretariat, Jaipur and the Vice-Chancellor, Rajasthan University of Veterinary and Animal Sciences, Bikaner, respectively, are directed not to declare the result of the selection process initiated by them against the post of Assistant Professor-Veterinary Anatomy". The Respondent Nos. 2 and 3 shall be at liberty to declare the result and complete the selection process qua all other posts, except for the post of Assistant Professor-Veterinary Anatomy.</p> <p>In compliance to the orders of Hon'ble High Court dated 06.11.2023, University requested the Principal Secretary to Hon'ble Governor, Raj Bhawan vide office letter No. 893 dated 06.11.2023 to allow the University to declare the results of all the selected candidates after convening the meeting of Board of Management of RAJUVAS per the directions of Hon'ble High Court. Hon'ble Governor of Rajasthan and Chancellor of University permitted the University to go ahead with the recruitment process in compliance of the directions of Hon'ble High Court dated 06.11.2023 vide its office letter No. 6251 dated 29.11.2023. In response to the Advt. No. 01/2023 dated 07.07.2023, sealed envelopes having results of various posts of different disciplines/subjects, except for the subject of Veterinary Anatomy, were opened before the Hon'ble Members of BOM in the meeting. As per the results, the House approved the selection of following candidates for different posts under various categories as per the details given below.</p>


