

**Minutes of the 6<sup>th</sup> Meeting of the Extension Education Council  
held on 14.02.2020 at 2:00 PM in the meeting hall of Vice-Chancellor Secretariat,  
RAJUVAS, Bikaner**

The 6<sup>th</sup> meeting of Extension Education Council was held on 14<sup>th</sup> February, 2020 at 2:00 PM in the meeting hall of Vice-Chancellor Secretariat, RAJUVAS, Bikaner under the Chairmanship of the Hon'ble Vice-Chancellor Prof. (Dr.) Vishnu Sharma. The list of members as well as invitees present in the meeting has been enclosed as **Annexure-I**.

The Member Secretary and Director Extension Education Prof. (Dr.) A.A. Gauri welcomed Hon'ble Vice-Chancellor, all the member of Extension Education Council, Invitees and Scientists particularly Dr. M.K. Sharma, MD, URMUL, Bikaner representative of MD, RCDF, Jaipur, Sh. Harish Chandra Sharma, Dy. Director (Agriculture) Soil & Survey, Krishi Bhawan, CAD, Bikaner, Sh. Mukesh Kumar Gahlot, representative of Dy. Director cum PD (ATMA), Krishi Bhawan, Bikaner, Dr. Virendra Netra. Dy. Director, representative of the Director, Animal Husbandry, Govt. of Rajasthan and Sh. Narendra Singh Tanwar, Progressive Farmer.

Prof. (Dr.) A.A. Gauri, Director Extension Education and Prof. (Dr.) R. K. Dhuria, PI, VUTRC informed the house about the agenda to be considered in the meeting and requested to Hon'ble Vice-Chancellor, Prof. (Dr.) Vishnu Sharma to initiate the proceedings of the meeting. The agenda of the meeting were taken one by one and resolved as follows.

**Agenda : EEC/06/A**

**Brief Introduction of the activities of the University by Hon'ble Vice-Chancellor**

At the outset, Hon'ble Vice-Chancellor Prof. (Dr.) Vishnu Sharma extended warm welcome to all the worthy members of the Extension Education Council. While briefing the house about the achievements as well as its activities, Hon'ble Vice-Chancellor in his opening remarks stated that University playing an important role in transfer of technology through one Krishi Vigyan Kendra at Nohar, Hanumangarh and fourteen Veterinary University Training and Research Centres (VUTRCs), established in various district of Rajasthan i.e. Suratgarh (Sri Ganganagar), Bakalia (Nagaur), Bojunda (Chittorgarh), Kumher (Bharatpur), Dungarpur, Dholpur, Lunkaransar (Bikaner), Sirohi, Tonk, Jhunjhunu, Kota, Churu, Jodhpur and Ajmer and covering 15 districts of Rajasthan. These centres are actively involved in the extension activities and working with the aim to uplift the socio-economic status of the rural masses. Hon'ble Vice-Chancellor stated that to strengthen the activities of the VUTRCs, it is essential to make liaison with the funding agencies like ICAR, ATMA, HRD etc., to organize sponsored trainings, gosthis, farmers' fair/ exhibition and other activities at VUTRCs. Hon'ble Vice-Chancellor also pointed out that disease diagnostic facilities should be strengthen on priority at VUTRCs so that



livestock farmers get benefitted. It was also informed that most of the VUTRCs are in need of farmers' hostel, so it was instructed that every Incharge of VUTRC should make contact with the public representatives i.e. MP's, MLA's etc for the financial assistance for the farmers' hostel. Training modules should be developed subject wise through Deans of the colleges and other faculty members. Local problems of the district should be identified and respective VUTRCs should provide the trainings and services to the livestock farmer according to the need identified. Every VUTRC should be expertize in one or two specific aspects of Animal Husbandry and Veterinary Science so that each VUTRC should make the identity of the centre in the whole district.

Dr. Manohar Lal Sain, Officer Incharge, Krishi Vigyan Kendra, Nohar, Hanumangarh-II presented the Annual Progress Report of Krishi Vigyan Kendra. During discussion, Officer Incharge requested about the filling of posts in KVK. A separate agenda was also included in this meeting for filling of the posts on urgent basis.

Prof. (Dr.) R.K. Dhuria, Principal Investigator, Veterinary University Training and Research Centre, RAJUVAS, Bikaner summarized all the activities carried out by VUTRCs in the year 2018-19 and 2019-20.

### **Presentation of Annual Report 2018-19 of VUTRCs by Incharges, VUTRC**

Respective Officer Incharges of VUTRCs presented the Annual Progress Report in the following order.

1. Dr. Raj Kumar Berwal, Incharge VUTRC, Suratgarh, presented the progress report. The house was in opinion that activities of VUTRCs can be popularize to social media. He instructed to other Officer Incharges regarding the use of social media like facebook, youtube, instagram, twitter. whatsapp etc. to disseminate the latest information regarding Animal Husbandry and Veterinary Sciences. He also instructed that fish pond proposal as discussed in the previous meeting was still not submitted. Officer Incharge assured to submit the revolving fund project proposal to establish the fish pond at centre within a month. House expressed the satisfaction about the progress.

2. Dr. Mahendra Tanwar, Incharge VUTRC, Bakalia (Nagaur) presented the progress report. He briefed about the steps taken for collaboration of ATMA (Agriculture Technology Management Agency) in training as well as in submitting of one goat project. He reported to house that a project of Rs. 4,99,370/- on goat was submitted to ATMA for sanctioning and this year four trainings was sanctioned by the ATMA for the first time. The house advised to other Officer Incharges of VUTRCs that they should take a step forward for their VUTRC and also submit the proposal according to the need of their area.

3. Dr. Mukesh Chand Sharma, Incharge VUTRC, Bojunda (Chhitorgarh) presented the progress report. He informed that goat farming is very popular in Chhitorgarh district. Vice-Chancellor instructed that VUTRC Bojunda (Chhitorgarh) should make specialization in the goat farming so that centre should make their identity in the state as the "Specialized Training Centre on Goat" and goat keepers should approached for any query about goat to this centre. The Officer Incharge also informed about the incomplete boundary wall and damaged road at the entrance of the LRS and VUTRC. These two issues were already discussed in Research Council Meeting in the report of LRS, Bojunda.

4. Dr. Ashok Baidya, Assistant Professor & Incharge VUTRC, Tonk presented the progress report and informed the house that the centre has been shifted from Tonk to Avikanagar (Tonk) in new building and the activities has been started from the new building. The building at Tonk is also handed over to Joint Director, Department of Animal Husbandry, Tonk.



5. Dr. Arun Kumar, Officer Incharge of the VUTRC, Kumher (Bharatpur) presented the progress report. He stated about the work done so far and briefed about the remaining repair work at the centre which has been completed. During discussion, it was resolved by the house that the activities like advisory services and farmers' scientist interaction should be replaced with other extension activities. **(Action: PI, VUTRC)**
6. Dr. Mukesh Chand Parashar, Incharge VUTRC, Churu presented the progress report. He informed the house that centre was shifted from the Churu in the newly constructed building at Ratangarh recently on 13.02.2020. Officer Incharge requested for construction of boundary wall of the centre. It was resolved that PI, VUTRC may submit proposal to Director Works to initiate the construction of boundary wall.

7. Dr. Atul Shanker Arora, Incharge VUTRC, Kota presented the progress report. Office Incharge briefed about the present status of construction work of building and fencing work at Polai Kalan, Kota. Officer Incharge informed that the construction work is stopped since last six month due to rainy season and water logging situation. Fencing works at centre is going on. It was resolved that Director Works should take up this problem at priority basis and complete the project well in time.

8. Dr. Rajesh Singhatia, Officer Incharge VUTRC, Dungarpur presented the progress report. It was resolved that every centre should make efforts to uplift the socio-economic status of the district particularly tribal population. For that extension activities should be according to their felt need and centre should make their identity among them.

9. Dr. Subhash Chand, Assistant Professor & Incharge VUTRC, Dholpur presented the progress report. During presentation, it was resolved in the house that all the Officer Incharge should submit the objective based annual report and also follow the target accordingly. It was also instructed that apart from the routine activities of the centre, new initiative should be taken by every VUTRC to make their identity in the respective district.

10. Dr. Tikam Chand Goyal, Incharge VUTRC, Jodhpur presented the progress report and informed the house about the present status of the newly constructed building. The Officer Incharge submitted that the electric connection in the building is under process and as soon as we get the electric connection, we will shift the centre in the new building.

11. Dr. Madan Mohan Mali, Incharge VUTRC, Ajmer presented the progress report and present status of land allotment process. Officer Incharge submitted that efforts are being made for land allotment process but still land is not allotted by the Government. House was of opinion that more efforts should be made for allotment of land at Ajmer.

ICAR-ATARI Jodhpur has repeatedly requested for appointment of SMS in the KVK, Nohar as per ICAR norms so that mandated work could be executed in the larger interest of farming community. Looking to the circumstances, it was discussed and resolved that for filling up the post in Krishi Vigyan Kendra, Nohar, Hanumangarh-II, a letter be written to Government of Rajasthan and Governor of Rajasthan referring to the meeting of Extension Education Council granting for permission to fill up the posts immediately.

The committee members shall prepare University rules for these training programmes.

The house emphasized that a meeting may be conducted with officials of Department of Gopalan, Govt. of Rajasthan for selection of one progressive Gaushala in respective district of VUTRC and for getting other financial support. The Council was in opinion that whatsoever the number of samples tested in the laboratory of VUTRCs, should be verified for authenticity. It was resolved that efforts should be directed towards the setup of the Disease Diagnosis and Milk Quality Testing facilities at each VUTRC on priority basis.

Gauri informed the house that looking to the budgetary constraints and repetition of the talk delivered by the expert, the RAJUVAS sponsored Radio Programme "*Dhine Re Batya*" may be broadcasted once in a month instead of broadcasting twice in a month. After discussion the matter was approved by the Council.

The Chairman invited the members of the Council if they have any specific comments or suggestions for betterment of extension activities being undertaken by the University including any future plan.

- Sh. Mukesh Kumar Gahlot, suggested that female participation should be atleast 30 percent in all the activities conducted by VUTRCs because in rural areas most of work related to livestock is being carried out by female.
- Dr. Virendra Netra, Dy. Director suggested that VUTRCs should take co-operation of animal husbandry personals to fulfil the extension activities / treatment camps of the district as per need.
- Sh. N.S. Tanwar pointed out that the impact of technology provided by the University to the farmers should be analyzed.
