Approval of the Annual Financial estimate for the current financial year 2012-13.

Resolution:-

The University has presented documents for both the above agenda items in the form of booklet entitled as "Budget 2012-13" containing page 1 to 25. The committee resolutions are;-

- 1). The expenditure statement for Plan/RKVY/ICAR/ Other/ MOET/UDF for the year 2011-12 provided at page No. 06 to 13 of the booklet was approved.
- 2). The committee also approved the Budget provision for 2012-13 pertaining to Plan/RKVY/ICAR/ Other/ UDF Annexure from Page No. 17 to 15.
- 3). The Comptroller intimated that the university is now allocating Rs. 2746.08 lacs only the committed provision with respect to State Plan as the budget of Rs. 1200.00 lacs on new items State Plan of 2012-13 is granted subject to clearance on file. The committee approved the utilization of committed provision for 2012-13 with respect to State Plan however, the budget of State Plan on New items of 2012-13 will be allocated after clearance on file by F.D. The committee was informed that the proposal of New item of 2012-13 State Plan to be cleared on file has been forwarded to the Govt. by the university. The Hon'ble Vice-Chancellor informed the house about the latest discussion on the matter he had with the Principal



Secretary, Plan and Finance and the New item of Rs. 1200.00 lacs covering 11 New Schemes for 2012-13 under State plan is under process at Finance Deptt. and is likely to be cleared soon. The committee approved the budget provision of 2012-13 from Page No. 17 to 25.

Thus the House approved the total expenditure of Rs. 66,96,73,492.25 for 2011-12 and the budget provisions of Rs. 84.00 Crore for 2012-13.

The House authorised the Comptroller for allocation of UDF budget according to the availability of accrued funds and sanction on the basis of actual and prioritized needs of the units.

Approval to fill-up the vacant posts under units of RAJUVAS and early action for creation of New posts.

Resolution :-

The committee approved the letter No. 145-148 dated 18.05.2012 for creation of New posts.

Approval to transfer the loan sanctioned by Govt. for pension purposes.

Resolution:-

The committee approved the loan of Rs. 194.25 lacs sanctioned by the Govt. vide letter No. F. 2 (22)AH/ 2011 dated 30.03.2011 and directed to act according to the guide lines.

Addl. grant under contingencies for 2012-13
The university put up before the committee the proposal for approval of Addl. Grant of contingencies under State Plan 2012-13.

The Comptroller explained that the Government has sanctioned Rs. 263.50 lacs contingencies under State Plan which is even not sufficient for 4 months expenditure. The actual expenditure incurred on contingencies grant (2011-12) was Rs. 803.45 lacs. The sanction for 2012-13 is in-adequate to meet out the need of the university. The Hon'ble Vice-Chancellor stated that the matter was raised at the Highest level in the Govt. (Planning & Finance Deptt.) and the proposals for

sanction of Addl. Grant of Rs. 708.50 lacs may be forwarded to the Govt. was approved by the house.

(II) Establishment of one New K.V.K. at Nohar.

The posts for establishment of one new K.V.K. under the Rajasthan University of Veterinary & Animal Sciences, Bikaner at Nohar have been sanctioned by F.D. vide order No. F.1 (1)Ag./3/2011 dated 06.06.12 creating 15 Nos. of New posts of various categories under ICAR for running the K.V.K. and the committee approved the establishment of one New K.V.K. at Nohar.
