MINUTES OF THE 9TH MEETING OF ACADEMIC COUNCIL

The ninth meeting of the Academic Council was held on 27th August. 2015 under the Chairmanship of the Hon'ble Vice-Chancellor Prof. (Dr.) Col. A.K. Gahlot.

At the outset, the Hon'ble Vice-Chancellor extended warm welcome to all the members of the Academic Council. He briefed the house about achievements of RAJUVAS as well as activities to be undertaken in near future. Further, The Hon'ble Vice-Chancellor also made the House aware about the ensuing meeting of VCI scheduled to be held on 28th August, 2015.

The Hon'ble Vice-Chancellor thereafter informed the House that the Hon'ble Governor and Chancellor has permitted for the First Convocation of RAJUVAS along with five more programmes for RAJUVAS during his stay at Bikaner from 15th to 17th August, 2015. On 15th, Hon'ble Governor and Chancellor will be gracing the Horse Show to be organized by 1 Raj NCC R&V Sqn between 6.00 to 7.00 PM. On 16th morning, at 10.30 AM Hon'ble Governor and Chancellor will move in the campus. First of all, a new wing of girls' hostel will be inaugurated by Hon'ble Chancellor, then inauguration of RAJUVAS Technology Museum as well as IUMS Center and at 11.30 AM, Hon'ble Governor and Chancellor will join the Academic Procession of the First Convocation. In the evening of 16th, At-home has been arranged in the welcome of Hon'ble Governor and Chancellor in the Front lawns of Bijey Bhawan in which dignitaries, guests, members of BOM and Academic Council as well as faculty will be invited. He also told the House that it will be historic visit of the Hon'ble Chancellor for us as he has consented for all the programmes proposed. He also conveyed that on 18th of this month, when he met the Hon'ble Governor and Chancellor, there was interaction for 17th programme for rural visit. Hon'ble Governor and Chancellor desired to visit to the adopted village of RAJUVAS. Therefore, Village Diaya, Near Nal, adopted by the University has been proposed. The Hon'ble Vice-



Chancellor appraised the House that it is very good opportunity for RAJUVS to show-case the achievements of RAJUVAS directly to the Hon'ble Governor and Chancellor. He apprised the House that on the occasion of Convocation, Sh. Prabhu LalJi Saini, Hon'ble Cabinet Minister for Animal Husbandry as well as Sh. Ota RamJi Devasi, State Minister for Gopalan have been invited as Guests for which they have agreed telephonically. Dr. N.S. Rathore, DDG (Education), ICAR has been requested to be our Guest and deliver Convocation Address. Consent in this regard has been received. The Hon'ble Vice-Chancellor further informed that we have also invited Dr. Umesh Chandra Sharma, President, VCI who has kindly accepted our invitation. It will be his first visit to Rajasthan as well as RAJUVAS. It will be a very good opportunity to show our achievements directly to the President, VCI.

It was also apprised by the Hon'ble Vice-Chancellor that in October, 2015, we are going to organize a National Seminar on 'Translational Research in Biotechnology for Improving Livestock Health and Production's
