

Minutes of the 25^d Meeting of the Academic Council held on 24.07.2023 at 11.00 AM in the Meeting Hall of Vice-Chancellor's Secretariat, RAJUVAS, Bikaner

The 25th Meeting of the Academic Council was held in hybrid mode on 24.07.2023 at 11.00 AM in the meeting hall of VC Secretariat, RAJUVAS, Bikaner under the Chairmanship of Hon'ble Vice-Chancellor, Prof. Satish K. Garg.

At the outset, Hon'ble Vice-Chancellor, Prof. Satish K. Garg extended warm welcome to all the members of Academic Council especially to the newly nominated members of Academic Council, namely Dr B.N.Shringi, Dr R.S.Pal and Dr Manisha Mathur and he hoped that with their experience and valuable suggestions, University will envision and devise new academic programmes. He also welcomed all the Hon'ble Members particularly external members Dr. Sanjay Kumar Sharma, GBPUAT, Pantnagar and Dr.Udeybir Singh, GADVASU, Ludhiana and officers and teachers from College of Veterinary & Animal Science, Navania & PGIVER, Jaipur those who attended the meeting through online mode and members from CVAS, Bikaner..

After opening remarks of the Hon'ble Vice-Chancellor, with the permission of chair, Registrar took up different agenda items one-by-one for discussion which were resolved as follows:-

25/02	To establish Department of Poultry Science in constituent Veterinary Colleges of RAJUVAS	The Chairman appraised the House that poultry is a fast emerging sector due to rapid urbanization and industrialization and has ample employment opportunities. He also apprised the House that VCI in its MSVE 2023 regulation draft has also proposed to have the separate Department of Poultry Science. On the recommendations of BSMA committee,ICAR has revised and restructured syllabus of Poultry Science to enhance professional skills for tackling emerging problems and generate employment opportunities in this sector.				
		During the course of discussion, it was agreed that separate Department of Poultry Science should be established in all the three constituent Veterinary Colleges of RAJUVAS. The House was informed that in CVAS, Bikaner, there are two separate posts of Assistant Professor Poultry Science. But to make the Department full fledged, it is necessary to man the Department with 01 Professor, 01 Associate Professor, 02 Assistant Professors, 02 Farm Managers, 02 Lab. Assistant and 02 Supporting staff as per MSVE 2023 Regulations.				
		It was resolved that the proposal of new Department of Poultry Science in all the constituent colleges of RAJUVAS with required manpower be sent to State Govt. With the existing staff of Department of Livestock Production & Management, MVSc degree programme in Poultry Science be started at COVAS, Bikaner from the Academic Session 2023-24. Concerned Deans will prepare proposal to establish Department of Poultry Science and submit to Registrar. (Action: Registrar/All Deans)				
25/03	To establish Department of Livestock Farm Complex (LFC) at College of Veterinary & Animal Science, Bikaner	The House was apprised that Livestock Farm Complex already existsin CVAS, Bikaner but is attached with Livestock Research Station, Bikaner with sufficient space. For LFC in CVAS Navania and PGIVER is already existing as or separate Department and there is no need to create LFC. Therefore, it was resolved that LRS will be within the LFC premises and LFC will be a constituent Department of Veterinary College under the administrative control of Dean, CVAS, Bikaner as				



		per MSVE Regulations. Further, the units of goats, sheep and piggery be also created in LFC for practical exposure to students as per MSVE Regulations.

Accordingly, a proposal be moved to the State Govt with requirements of staffing pattern and other requirements as per VCI Regulations. Concerned Deans will submit the draft-proposal to the University (Registrar/Deans, CVAS Navania/PGIVER)
25/06	To approve Post Graduate Academic Regulations 2023 of RAJUVAS, Bikaner as applicable on the students admitted from the academic session 2022-2023.	After a detailed deliberation, it was resolved to approve the Post Graduate Academic Regulations 2023 of RAJUVAS, Bikanerwith following modifications. 1. A plagiarism check certificate as Certificate VII will be submitted by the Scholar and Major advisor, that the thesis has been subjected to plagiarism check using the antiplagiarism software and research work is original. 2. Regarding comprehensive examination of M.V.Sc and Ph.D students, guidelines of ICAR-BSMA committee will be followed from the academic session 2022-23. 3. M.Sc/MVSc degree programme in Animal Biotechnology will be started after sanctioning of posts by Government of Rajasthan for the Department of Animal Biotechnology. Further, M.V.Sc degree programme will also be started in the



subject of Poultry Science from 2023-24.

- In case a student fails to take re-admission within the permissible duration of two weeks, his/ her admission shall stand automatically cancelled.
- 5. At point no 12.4, If a student fails to attend the classes continuously for a period of 15 days in a semester without permission of the Dean of the college, his/her name will be removed from the college rolls and he/she may have to seek re-admission next time as a fresh candidate. No petition is permitted in this case.
- M.V.Sc/Ph.D. scholar will be allowed to attend Training /Conference /Seminar /Symposium of National level in concerned subject only.
- 7. Maximum 10 day so absence including travel period in a semester shall be allowed on production of certificate by the student deputed to represent college and university in training/conference/seminar of National level.
- 8. Once the thesis is submitted by the student in loose or hard bound form it should be sent to Dean PGS by the concerned Deans within three days time period.
- 9. All the Ph.D.students shall write and submit two quality research publications for peer reviewed journals having NAAS rating not below 6. Ph.D student shall produce the evidence of two submitted research papers to are ferred journal at the time of final submission of thesis to Dean PGS, failing which Thesis will not be accepted.M.V.Sc.students shall produce evidence of one submitted research paper in peer reviewed journal not below the NAAS rating 6 at the time of final submission of their thesis to DeanPGS, failing which Thesis will not be accepted.
- 10. Further Dean PGS was authorized to incorporate some minor corrections suggested by the members of academic council during discussions.
