27/02	<p>Proposal to start AHDP Programme from Academic Session 2024-25 with 50 seats at CVAS, Jodhpur</p> <p><u>Agenda :</u> Dean, College of veterinary and Animal science, Jodhpur vide letter No. F. ()/ CVASJ/RAJUVAS/Acad/2024725/ 143-144 dated 22.06.2024 has proposed to start AHDP Programme from Academic Session 2024725 with 50 seats at CVAS, Jodhpur. Presently, there are 19 teachers in the College. Most of the laboratories of the departments of 1st and 2nd BVSc & AH are well equipped. Hostels (boys and Girls) are also ready and furnished with cots, tables, and chairs. If VCI is unable to arrange the early inspection of the College and does not allow start permit BVSc & AH programme, the infrastructure and facilities created may remain unutilized for whole year and it may lead to unnecessary audit objections as well as has been objected in CDST, Bikaner and CDFT, Bassi, Jaipur due to majority of seats which remained unfilled after admission during 2022. Therefore, as per provision law in RAJUVAS Act</p>
	<p>After detailed discussion, the House found it fruitful that to utilize the man-power, physical facilities, equipped lab. etc. available at CVAS, Jodhpur and unanimously resolved to approve the proposal in principle to issue notification as per the provision of the Act and Statutes of RAJUVAS.
