The Divisional Commissioner asked about the jurisdiction of the University. The Dean informed that jurisdiction of the University extends to the entire Rajasthan State. The Comptroller and the Dean explained the various activities under taken by these centres.

Approval of the Annual Financial Statement for current financial year 2017-18.

Resolution:-

Page No. 49 to 66 show the Annual Financial Statement for the current financial year 2017-18 for the budget received & allocation under State Plan, SLSC approved budget for RKVY, demand proposal under ICAR D.S. and likely receipts for UDF. The estimated budget for 2017-18 amounts to Rs. 121.97 crores which is 18.39 % less than that of the previous year. The Comptroller explained that the decrease was mainly due to significantly lower allocations in RKVY budget. New items under State Plan with Rs. 500.00 lac subject to clearance on file cleared and sanctioned.

The Comptroller invited the attention of the members on the decrease of RKVY budget during current year and no allocation of budget from 2018-19 under RKVY as per SLSC decision. The Dean informed the status and research progress of the Cattle farms and insisted the continuance of the cattle breeding farms in the light of the progress made as well as the need for feed & fodder and maintenance of the ...... No. of cattle in these farms. The Committee asked for the alternative means for these farms. The Comptroller proposed to get these farms incorporated under the State Plan. For the current year the funds can be met out of the savings of salary against vacant posts. Which were to be filled up but the recruitment process has been kept in abeyance by the Hon'ble Chancellor till further orders. The Comptroller also proposed for reappropriation of the remaining funds of the salary savings against Hostel construction and sports complex (Capital works). The Committee approved the estimated budget along with proposals of Cattle breeding farms and re- appropriation there upon.
