MINUTES OF THE 8TH MEETING OF ACADEMIC COUNCIL HELD ON MARCH 09, 2015

Eighth meeting of the Academic Council was held on 9th March, 2015 under the Chairmanship of the Hon'ble Vice-Chancellor Prof. (Dr.) Col. A.K. Gahlot. At the outset the Hon'ble Vice-Chancellor extended warm welcome to all the members of the Academic Council. Hon'ble Vice-Chancellor briefed the House about achievements attained after the last meeting of the Council as under:

He apprised the House of the recent visit of Dr. S. Ayyappan, Secretary, DARE and Director General, Indian Council of Agricultural Research, New Delhi at Udaipur campus on 01.03.2015. During the visit, Hon'ble DG addressed the faculty members at Navania, Vallabhnagar and expressed happiness to see the team of young faculty members at that campus. Hon'ble Vice-Chancellor apprised the Hon'ble DG about the progress of various schemes funded/sponsored by ICAR at Navania. He was quite satisfied to see the exhibition of various techniques developed by RAJUVAS during Kisan Mela at KVK, organized by Vidhya Bhawan Society at Udaipur. While briefing about the News Letter, *Pashupalan Naye Aayam* and *Pashu Ahar Evam Chara Bulletin* by Hon'ble Vice-Chancellor, being published by RAJUVAS, the DG had shown his personal interest and appreciated the publications.

The House was apprised of about one successful event of completion of one cycle of recruitment of faculty, selecting 121 new faculty members, out of which, 108 has joined. The House congratulated the Hon'ble Vice-Chancellor for successful completion the first phase of huge recruitment as it remains an example in the country for any University to recruit such a large number of faculty members in one go. The Hon'ble DG hoped that by utilizing the available human resource, RAJUVAS can train more and more number of persons for higher education in the field of veterinary and animal sciences. During the discussion, he also showed worry about shortage of human resource throughout the country as even Assistant Professors are also not available in many of the disciplines in the faculty of veterinary and animal sciences.

Hon'ble Vice-Chancellor also mentioned about increase of total number of seats in all the 4-tier programs after establishment of the University and also after the last Academic Council meeting. He told that the number of ADHP institutes has reached to as high as 65 which is a big goal for RAJUVAS. He also told that the State Government has started taking keen interest in this programme which directly makes the youth self-employed. Hon'ble Vice-Chancellor told that during the last budget session the total number of intake capacity was increased to 100 in both the constituent colleges. We had PG and Ph.D. counselling on 18th Feb., 2015. Before this counseling also we increased the number of PG and Ph.D. seats at PGIVER, Jaipur, CVAS, Bikaner and CVAS, Navania. The House was also appraised of about successful conduction of RPVT-2014

Hon'ble Vice-Chancellor told that since the Hon'ble Governor and Chancellor is pressing very hard for conduction of Convocation regularly, RAJUVAS is going to conduct its First Convocation very shortly and we have initiated actions in this regard. It is expected that in the month of April, 2015, we will be holding our First

Convocation and we will be able to distribute about 1126 degrees to pass out students and will clear all backlog.

The House was also made aware that plan-ceiling has been increased for the current financial year, with great efforts by the Comptroller and DPME. The plan ceiling for this year has been increased from Rs. 50.25 crore to Rs. 53.70 crore. We have received funds for NCC R&V Regiment sanctioned at Navania (1.35 + 1.45 Cr) and we will be having two more hostels one for boys and the other for girls at CVAS, Navania with the funds of Rs. 6.0 cores. With this new facility, it is hoped that for next ten years, the hostel facility at Navania campus will be sufficient. It is hoped that in near future approach to Navania campus will be easy and lots of problems will be solved particularly of transportation.

The House was apprised of the welcome trend seen in a recent training imparted using hydroponics technique in which farmers from Nagaur, Suratgarh as well as from Taranagar participated on their own. One of the farmers' leader requested to the Hon'ble Vice-Chancellor for providing trainings to women farmers, as he was ready to bring literate girls and women for trainings on various aspects of animal husbandry for one to two days. Hon'ble Vice-Chancellor assured them to start such type of training programme very soon. In this connection, Hon'ble Vice-Chancellor expected from the faculty to identify the thrust areas as per need of the State as large number of faculty and expertise are available in the University at different campuses. He also expected from the faculty to adopt the concept of 'one lab' or 'lab for all' at each campus by procuring facilities from other departments and students may be sent to other campuses, where better research facilities are available. We can also take the help of NRCC, CSWRI, NRCE, where good lab facilities are already available. The Departments may chalk out the plans of trainings of 2-3 weeks to one year also.
