Minutes of the 7th Meeting of Academic Council held on 28th June, 2013

The Seventh Meeting of Academic Council of Rajasthan University of Veterinary & Animal Sciences, Bikaner was held on 28th June, 2013 at Conference Hall of ABG Department, CVAS, Bikaner under the Chairmanship of Prof. (Dr.) Col. A.K. Gahlot, Hon'ble Vice-Chancellor. The list of participants is as per *Annexure-1*.

Hon'ble Vice-Chancellor welcomed all the members of the Academic Council. He extended thanks to the Government as well as H.E. the Governor and Chancellor of the University on behalf of the house for extending the term of Prof. A.K. Gahlot, Vice-Chancellor w.e.f. 18th May, 2013 for a period of one year on completion of the first term of 3 years.

Hon'ble Vice-Chancellor briefed the House about the achievements attained after the last meeting of the Council as under:

The House was appraised of the meeting with H.E. the Governor held on 10th June, 2013 at Raj Bhawan, Mt. Abu, in which a presentation on "Tribal Sub Plan" (TSP) was made along with the team of CVAS, Navania and PGIVER, Jaipur. H.E. Smt. Margaret Alva conveyed her appreciation and thanks for making developments in teaching and Research, specially for the innovative ideas and work undertaken for the development of Tribal Area, by RAJUVAS and suggested to undertake survey of Sirohi district to prepare an action plan for Tribal area. At the end of presentation, she released the CD of "RAJUVAS SONG". Hon'ble Vice-Chancellor extended thanks to Public Relation Cell for preparation of Song as well as publication of articles pertaining to University with the magazines like, SUJAS, SHARAD KRISHI, Manak etc. being published at National and State level.

RPVT-2013 was successfully conducted on 9th June, 2013 through which admissions for the academic session 2013-14 will be provided to all the constituent as well as affiliated veterinary colleges. Hon'ble Vice-Chancellor also informed that meeting of Finance Committee of the University was held on 20th June, 2013 in which budget for the financial year 2013-14 was got approved amounting to around Rs. 119.00 Cr. which is eight times of pre-university formation budget.

Hon'ble Vice-Chancellor met with DDG (AS) and DDG (Edu.) at New Delhi was held on 30th May, 2013. It was informed that three AICRPs are to be sanctioned for which consent has been sent to CIRG and NIANP and MOUs are to be signed shortly by RAJUVAS. Two AICRPs are on goats and one on enhancing reproductive efficiency..

Hon'ble Vice-Chancellor informed the House that first grant of Rs. 2.00 crores under Development & Strengthening is likely to be received from ICAR. It was also informed that in the meeting of SLSC for RKVY held on 17th June,2013, a fund of Rs. 22.00 crores has been sanctioned to RAJUVAS to meet out the requirements of projects. In the meeting, the Jt. Commissioner Animal Husbandry, GOI appreciated the work of RAJUVAS particularly running on indigenous livestock breeds.



Hon'ble Vice-Chancellor briefed about his participation in the seminar on "Capacity Building for Skill Development and Self-Employment in Livestock, Poultry and Fisheries Sectors" on 12th and 13th April, 2013 held at TANUVAS, Chennai. He desired to identify trainings for skill development to be taken up at different campuses of RAJUVAS, for which Committee may be constituted to examine and prepare the course modules for skill development.

He also emphasized need to establish Institutional quality assurance committee.

Looking to the strengths of the University, a batch of Animal Husbandry Officers from Punjab has been deputed for get Goat Husbandry training at our campus.

Thanks were extended to Hon'ble Chief Minister for sanctioning Sahiwal Cattle Breeding Farm to RAJUVAS and also sanctioning a fund of Rs. 15.00 crore for establishment of the same. Hon'ble Chief Minister has consented to inaugurate the farm in near future.

It was informed to the House that a grant of Rs. 894.00 lakhs as 1st instalment has been received from the Government of Rajasthan under State Plan.

RAJUVAS is going to publish a magazine in Hindi containing the latest technologies for information and knowledge to progressive Cattle Farmers.
