

The Comptroller invited the attention of the members towards the Hon'ble C.M.'s budget declaration 2016-17 for enhancement of stipend of P.G. from Rs. 5000/- P.M. to 10000/- P.M. with an additional provision of Rs. 165.00 lac under State Plan budget 2016-17. The budget under ICAR DS/ ICAR for 2016-17 has been estimated on the basis of previous year releases. The Committee approved the estimated budget provision of 2016-17 (Page No. 49 to 71).
