CONDITION OF SUPPLY

- 1. Rate should be quoted for genuine quality euipments with suitable warranty (as per specification provided)
- 2. Rate quoted should be F.O.R., CVAS Navania and inclusive of all taxes.
- 3. Supply will have to be made within one nonth from the date of the order.
- 4. The quotation shall be valid for a period of two month from the acceptance.
- 5. After a quotation has been accepted the rates shall remain valid for the period 15th June, 2023 to 31st March 2024 and then the period can be extended by mutual agreement.
- 6. No counter proposals or modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the order is submitted in response to our quotation notice, it will be applicable to acceptance of terms and conditions given by us and no claims will be entertained. In other words, firm intending to given counter proposals should not submit tender at all.
