**CONDITION OF SUPPLY**

2. Rate quoted should be F.O.R., CVAS Navania and inclusive of all taxes.
3. Supply will have to be made within one month from the date of the order.
4. The quotation shall be valid for a period of two month from the acceptance.
5. After a quotation has been accepted the rates shall remain valid for the period 15<sup>th</sup> June, 2023 to 31<sup>st</sup> March 2024 and then the period can be extended by mutual agreement.
