



1.0 Scope of work:- Provide project engineer for civil projects.

- a) Consultant should provide full time project engineer/ engineers to assist in supervision of various sites of university allotted under CVAS, Navania, Vallabh Nagar. This project engineer will supervise the works; prepare bills jointly with contractor and university engineer if any under estate office with detail measurement in Measurement Book format. He will also assist in preparing estimates, tender documents etc. This civil engineer should be Degree holder/Diploma Holder & should well acquaint with Rajasthan PWD specifications, BSR, mode of measurements etc. he will also be able to conduct & prepare quality control test record regularly.
- b) Head quarter of this project engineer shall be CVAS, Navania, Vallabh Nagar, Udaipur.
- c) Engineer may be asked to visit & work at sites other than his head quarter. In this condition he shall be paid bus/train fare or provided office vehicle if deemed necessary.
- d) If project engineer is retired from govt./semi govt. organization, he may be allowed Taxi Car for visit site outside the head quarter after permission of the Dean if they wish.

2.0 General conditions

- 2.1.1. Consultant firm should provide Degree holder (with 10 years of experience)/Diploma holder (with 15 years of experience) or equivalent having experience of handle civil projects or he should be retired from govt./semi govt. organization from a post of JEn or AEn. Individual should provide copy of all documents before joining duty.
- 2.1.2. Project Engineer should report within **Five days** after work order.
- 2.1.3. Certificate copy of Degree, Experience certificate, PPO certificate (if retired from Govt./Semi Govt. organization) must be submitted for approval before sending the engineer on duty.
- 2.1.4. As per condition taxi car shall be allowed for visit sites outside the head quarter for person if retired from Jen./AEn. (from Govt./Semi Govt. organization)
- 2.1.5. The rates approved shall be valid till 31.03.2024 from the date of work order & may be extended for 6 months if required.

3.0 Professional Fees

7.2. If the Consultant shall close the business or dies or becomes incapacitated from acting as such, then the agreement shall stand terminated.

7.3. If the Consultant fails to adhere to the time schedule stipulated in the schedule hereto annexed of the extended time which may be granted by the employer in its sole discretion or in case there is any change in the constitution of the Engineer for any reason whatsoever, the college shall be entitled to terminate this agreement and entrust the work to another Agency.

8.0 Transfer of Interests

Neither the college nor the Consultant shall assign, sub-let or transfer their interest in this agreement, without the written consent of the other.

9.0 Arbitration

If any disputes, difference or question of any nature arises at any time between the parties or their respective representatives, successors regarding the terms & conditions and execution of this Agreement or concerning anything herein contained or arising out of this Agreement or as to rights, liabilities or duties under this Agreement of the parties hereto respectively, except in respect of matter for which it is provided herein that the decision of the employer will be final and binding, the same shall be referred to arbitration of a single Arbitrator in accordance with the provisions of the Arbitration Act. 1940 or any modification or re-enactments there to for the time being in force. In the event of disagreement as to the appointment of a single Arbitrator, the parties shall appoint one Arbitrator each, and the Arbitration Authority so appointed shall make its award within one year from the date of reference made to the Authority. The Arbitration proceedings shall be held at Udaipur.
