# Memorandum of Understanding between Rajasthan University of Veterinary and Animal Sciences, Bikaner

### and

# Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University, Jodhpur

This memorandum of understanding is made by and between the Rajasthan University of Veterinary and Animal Sciences, established under the Rajasthan University of Veterinary and Animal Sciences Act, 2010 (Act No. 13 of 2010) and having its headquarters at Bikaner and with assigned jurisdiction of whole of the Rajasthan State (hereinafter referred to as RAJUVAS and called the First Party)

#### and

Dr. Sarvepalli Radhakrishnan Rajasthan Ayurved University, established under DSRRAU Act, 2002 (Act No. 15 of 2002) and having its headquarters at Jodhpur (hereinafter referred as Ayurved University and called the Second Party)







#### Preamble:

- 1. Whereas the First Party, RAJUVAS is a premier University actively involved in veterinary education, research, and extension having jurisdiction all over the State of Rajasthan through its constituent colleges, research & extension units and affiliated colleges. The RAJUVAS is having large livestock farms at the headquarters (Livestock Research Station, CVAS, Bikaner), Livestock Research Station, Kodamdesar, Bikaner, Livestock Research Station, Beechwal, Bikaner, Livestock Research Station. Chandan, Livestock Research Station, Vallabhnagar and Livestock Research Station, Nohar actively involved conservation and improvement of indigenous breeds like Rathi. Sahiwal, Kankrej, Tharparkar and Gir cows; Surti buffaloes; and sheep and goats. The RAJUVAS also has a team of trained manpower and the state of art laboratories, facilitating basic and applied research.
- 2. Whereas the First Party recognizes the importance and requirement of the Panchyagavya technology for the benefit of the society in general and farming in particular and also feels that there may be many more areas of common interests requiring cooperation and collaboration of both the parties.





3. Whereas, the Second Party is a renowned Ayurved University mandated with the teaching and research in the areas of Ayurveda including alternate medicine, and having strength of outstanding scientists working in many related fields, including Panchagavya, alternative medicine etc.

The First and the Second Party understand the need and scope of cooperation and the collaborative research in some of the programmes to join hands.

### Terms of MoU

- 1. RAJUVAS, Bikaner and Ayurved University, Jodhpur shall identify scientist(s) of respective Universities to explore suitable areas of collaborative research and work plan on Panchagavya and other possible areas.
- 2. A joint follow up committee may be set to periodically review the execution of collaborative research and suggest measures, if any, to further develop the understanding and areas of research.
- 3. The intellectual property, research publication and benefits arising out of the commercialization of jointly generated technologies shall be jointly owned by RAJUVAS and Ayurved University.







- 4. Both the parties, with mutual consent may add, delete or modify the word, phrase, sentence or terms of MoU.
- 5. The MoU shall be effective from the date of signing by both the parties and shall remain in operation for three years, subject to renewal after three years or termination with mutual consent.
- 6. Any dispute arising out of MoU's execution/ provisions or otherwise shall be subject to solution by mutual agreement and if not solved mutually, then through arbitration by an Arbitrator, jointly agreed and appointed by both the parties.
- 7. This MoU will come into effect from date of last signature.
