
Terms and conditions:-

1. GST 18% extra.
2. F.O.R:- Central Store, CVAS, Bikaner.
3. Validity:- upto 31.3.2025
4. Judicial area: Bikaner.
5. Delivery:- All the rates are F.O.R. Destination (Free Delivery at CVAS, Central Store, Bikaner and inclusive of packing forwarding, freight, insurance, loading and unloading charges). The above items should be supplied within 15 days from the date of supply order. Liquidated damages shall be recovered at the prescribed rates, if the firm fails to supply within the supply period, provided that the ordering authority on the request to the firm may be extend the supply period before its expiry after being satisfied with the reason given by the firm for inordinate delay in supplies. However, the extension of supply period may be with or without liquidated damages. In case of extension in the delivery period with liquidated damages recovery shall be made on the basis of the following percentage of value of stores which the firm has fail to supply:-
 - i) Delay upto one fourth period of the prescribed delivery:- 2.5%
 - ii) Delay exceeding one fourth but not exceeding half of the prescribed delivery period:- 5.0%
 - iii) Delay exceeding Half but not exceeding three fourth of the prescribed delivery period:- 7.5%

- iv) Delay exceeding three fourth of the prescribed delivery period:- 10.0%
6. Other conditions of the contract shall remain the same as given under terms and condition of the tender.
 7. Supply shall be accepted strictly according to the specification like make etc. as mentioned in the bid/order.
 8. Final decision will remain with Dean's power to decrease/ increase of the quantity of approved items.
 9. The firms will execute an agreement (format enclosed) on Rs. 500/- Non-Judicial Stamp with the Dean,CVAS ,Bikaner for and on behalf of Rajasthan University of Veterinary and Animal Sciences, Bikaner.
 10. The Bid Security Rs. 5600/- already deposited by you will be converted into performance security. Further, you will have to deposit Rs. 8855/- through Banker cheque/DD/Cash as 5% performance security of the entire supply of payment of bill amounting to Rs. 2,89,100/- which will be kept pending till entrie supply is made. The bid performace security will be refunded after successful completion of tender validity.
