



**CONDITION OF SUPPLY:-**

- 1 Rate should be quoted for good quality of **Feed ingredients**.
- 2 Rate quoted should be FOR, CFMMP, Bikaner inclusive of all taxes.
- 3 Supply orders will be issued as per demand from store in parts. Supply will have to be made within 03 days from the date of the order.
- 4 After a Limited tender has been accepted, the rates shall remain valid for the period upto six months. The period can be extended by mutual agreement.
- 5 No counter proposals or modifications by the party will be acceptable The counter proposals stated in the tender will be ignored and once the order is submitted in response to our tender notice, it will be made applicable to acceptance of terms and conditions given by us and no claims will be entertained. In other words, firm intending to give counter proposals should not submit tender at all.
- 6 Alternative specifications will not be acceptable.
- 7 **Feed ingredients** should be strictly according to specification is attached.
- 8 Cost of shortage and warfare during transaction would be deducted from the relative bills. No extra cost on such account will be admissible.
- 9 Limited tender received after the prescribed time and date will be rejected.
- 10 On the cover containing the Limited tender should be written "Quotations for the supply of **"Feed ingredients"**". The purchasing officer is not bound to accept the lowest tender.
- 11 The decision of accepting authority shall be final as to the quality of the stores.
- 12 Then rejected articles will have to be removed by the tender at his own cost.
- 13 In case of local supplies the rates should include all the taxes and no cartage or charges for transportation will be given by the Firm and the delivery of the goods shall be given at the premises of the University.
- 14 Limited tender should be filled in INK.
- 15 Remittance charge on payment made to the firm will be borne by the firm.











- 16 The insurance charge will have to be borne by the supplier, if necessary.
- 17 No advance payment will be made.
- 18 All legal proceeding if there is any necessary to institute by any of the parties (University counterpart) shall have to be legated in the courts situated at Bikaner and not elsewhere.

- 20 The quantities shown in the list are approximate.
- 21 No. shortpenalty/rate difference shall be imposed if the supplies are to the extent of + 5% of the ordered quantity



### SPECIFICATION FOR GRAIN

Grain such as Maize should be in sound merchantable condition, dry, hard, clean, wholesome, of good food value, uniform in colour and size of grains and free from visible moulds, fungus, weevils, musty or other objectionable odour, discolouration, extraneous matter, adulterants harmful constituent, insect infestation, fermentation, rancidity, sprouting, foreign bodies, including weed seeds, admixture of deleterious substances and impurities etc. except to the extent the :-

- i) Specification for food grains
- ii) Specification for other raw materials


