

- 1. Firm should be GST registered
- 2. Rate should be quoted for good quality and for long term use preferably ISI Mark (as per specifications provided)
- 3. Rate quoted should be F.O.R., CVAS Navania and inclusive of all taxes.
- 4. Supply will have to be made within one month from the date of the of work order.
 - (s) The quotation shall be valid for a period of two month from the acceptance.
 - (t) After a quotation has been accepted the rates shall remain valid for the period 28.01.2024 .to 31th March 2025 and then the period can be extended by mutual agreement.
- 5. No counter proposals or modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the order is submitted in response to our quotation notice, it will be applicable to acceptance of terms and conditions given by us and no claims will be entertained. In other words, firm intending to give counter proposals should not submit tender at all.
- 6. Alternative specifications will not be acceptable.
- 7. Article should be strictly according to specifications and all the requirement for installation has to be born by the supplier. Only the electric connection will be given by College
- 8. Cost of breakages, shortage and warfare during transaction would be deducted from the relative bill. No extra cost on such account will be admissible.
- 9. Quotations received after the prescribed time and date will be rejected.

- 11. The Procurement Entity is not bound to accept the lowest tender.
- 12. The decision of accepting authority shall be final as to the quality of the stores.
- 13. Rejected articles will have to be removed by the tender at his own cost.
- 14. In case of local supplies the rates should include all the taxes and no cartage or charges for transportations be given by the college and the delivery of the goods shall be given at the premises of the CVAS Navania.
