**CONDITION OF SUPPLY:-**

1. Firm should be GST registered
2. Rate should be quoted for good quality and for long term use (as per specifications provided)
3. Rate quoted should be F.O.R., CVAS Navania and inclusive of all taxes.
4. Supply will have to be made within one month from the date of the of work order.  
(q) The quotation shall be valid for a period of two month from the acceptance.  
(r) After a quotation has been accepted the rates shall remain valid for the period 28.01.2024 .to 31<sup>th</sup> March 2025 and then the period can be extended by mutual agreement.
5. No counter proposals or modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the order is submitted in response to our quotation notice, it will be applicable to acceptance of terms and conditions given by us and no claims will be entertained.
