GENERAL GUIDELINES FOR THE CANDIDATES

- Candidates are advised to read the information booklet very carefully before filling up the online application form.
- Admissions to Post Graduate Degree Programme (M.V.Sc./Ph.D.) will be made based on score in **ICAR-AIEEA (PG) 2024** and **ICAR AICE-JRF/SRF (Ph.D.) 2024** examination, whichever is applicable.
- Candidates shall have to pay the application fee amounting to Rs. 2500/- (applicable for all categories) through NET banking/Debit Card using online gateway mode only available on University website www.rajuvas.org.

Eligibility Criteria for M.V.Sc and Ph.D. Admission:

Indian Nationals of Rajasthan domicile only will be eligible for admission on State and Payment seats for M.V.Sc. and Ph.D. degree programmes. The valid domicile certificate has to be produced by the candidate at the time of counseling. The relevant certificates of eligibility of the candidate will have to be furnished by the candidate at the time of counseling.

M.V.Sc. Degree Programme:

- The candidate must have passed B.V.Sc. & A.H. degree examination with not less than 6.0/10.0 or equivalent OGPA/equivalent percentage (i.e. 60%) of marks for general category candidates and 5.5/10.0 or equivalent OGPA/equivalent percentage (i.e. 55%) of marks for OBC/SC/ST/STAMBC/EWS/PH/Defense/any other applicable category as per reservation policy of Govt. of Rajasthan.
- For Master's degree programme, the candidate must be Rajasthan Domicile except the candidates nominated by ICAR and must possess bachelor's degree in the concerned faculty or the degree equivalent thereto from any other recognized University or Institute with a minimum percentage of marks as prescribed along with other provisions. The admissions shall be made on the **basis of score in ICAR-AIEEA (PG) 2024** examination conducted by NTA/ICAR. State Reservation Policy will be applicable on all the admissions for State quota seats.

Ph.D. Degree Programme:

- The candidate must have passed Master's degree in respective/related subjects with not less than 6.5/10.0 or equivalent OGPA/equivalent percentage of marks for general category candidates and 6.0/10.0 or equivalent OGPA/equivalent percentage of marks for SC/ST/STA/OBC/MBC/EWS/PH/Defense any other applicable category as per reservation policy of Govt. of Rajasthan.
- For Ph.D. degree programme, the candidate must be Rajasthan Domicile except for the candidates nominated by ICAR and must possess Master's degree in the concerned subject or a degree equivalent thereto from any recognized University or Institute with minimum percentage of marks as prescribed and other provisions. The admissions shall be made based on score in **ICAR AICE-JRF/SRF (Ph.D.) 2024** examination conducted by NTA/ICAR. State Reservation Policy will be applicable on all State Quota Seats.

Important Note:

1. There will be **one (01) supernumerary seat** in M.V.Sc. & Ph.D. degree programme in each discipline reserved for **field functionaries** working as Veterinary Officer/Senior Veterinary Officer/any other permitted designation and issued NOC for pursuing higher studies by the Department of Animal Husbandry, Government of Rajasthan or any other employer at the time of admission.
2. **One additional seat** in each department is created as **Supernumerary Seat** in M.V.Sc. and Ph.D. degree programme **for the candidates belonging to Other States.**
3. The following **categories are exempted** from appearing in **ICAR-AIEEA (PG) 2024** and **ICAR AICE-JRF/SRF (Ph.D.) 2024** examination:
 - a) Candidates nominated through ICAR//GOI/Foreign nationals.
 - b) Field functionaries are deputed by their respective employers.
 - c) In-service candidates of RAJUVAS and/ or considered as "in service" on receipt of their applications through their employers will be required to fulfill the minimum academic qualifications.

However, they have to fill the online application form and fee for admissions in PG and Ph.D degree programme with in stipulated time line.

4. **International students** will normally be considered for admission to PG degree programmes under the category of ICAR nominees on the seats reserved for ICAR, if no such ICAR seat is vacant, then even additional seats to be created by the university for such candidates.
5. **Foreign sponsored/nominated** through ICAR shall be required to pay bench fee as prescribed by ICAR or any other authority of Govt. of India. The terms and conditions set by ICAR or any other authority of Govt. of India shall be applicable to such students.
6. Admission to any study programme in the University cannot be claimed by a candidate as a matter of right. In case, a person is refused admission by the Admission Board based on any specific reason despite his/her having secured such merit by which he/she stands higher than the last admitted candidate of his/her category, such candidate will be given a hearing by the Admission Board. The decision of the Vice-Chancellor in this regard shall be final.

RESERVATION OF SEATS FOR ADMISSION

The reservation policy of Government of Rajasthan will be followed for admissions to Master's and Ph.D. programmes, however, in the event of any seat falling vacant due to non-availability of applicants/candidates of a particular reservation category from the reservation quota or UR or that reserved for ICAR, then such vacant seats shall be filled up with the students belonging to any other categories as per the State Reservation Policy.

DENIAL AND CANCELLATION OF ADMISSION

- a) The admission of an applicant suppressing any information or giving wrong information or facts or forging his/her signature or of his/her parents or attaching false certificates shall be cancelled at any stage before or after admission as well as during progression of the degree programme, which shall be in addition to any other punishment that may be awarded to him/her for concealment of facts.
- b) Following candidates shall not be given admission in any of the constituent colleges of the University, even if they are qualified in **ICAR-AIEEA (PG) 2024** and **ICAR AICE-JRF/SRF (Ph.D.) 2024** examination:

- i. A candidate against whom any FIR has been lodged by the University or any of the constituent or affiliated private veterinary colleges or by any other competent authority/officer of the University.
- ii. A candidate who has been punished by the university under Rules of Discipline.

GENERAL GUIDELINES FOR COUNSELING

1. All candidates willing to take admission shall report positively on notified date for counseling before a committee constituted by the Dean and Chairman Faculty.
2. The candidates will not be issued any letter to attend counseling.
3. The final merit list shall be prepared by the Committee for admission in each Major subject.
4. There is no provision of TA/DA to the candidates for attending counseling by the University.
5. The admission to various programmes will be done strictly on the basis of merit while strictly following the reservation policy of Government of Rajasthan.
6. The candidates eligible for counseling of M.V.Sc. course programme will be asked for an option of sub-subject from the Major subjects' groups (Veterinary Science/Animal Science /Animal Biotechnology- Veterinary Biochemistry only) strictly as per eligibility in particular major subjects' groups already opted in entrance examination and entertained only for that subjects/College for which the vacancy is available at the time of counseling.
7. Candidate securing equal marks in the **ICAR-AIEEA (PG) 2024** and **ICAR AICE-JRF/SRF (Ph.D.) 2024** examination will be admitted in the following order of preference: one who has secured more marks in the Master's/Bachelor's Degree examination followed by Senior Secondary Examination (10+2) or its equivalent.
8. The University reserves the right to admit or reject admission of any candidate without assigning any reason.
9. If for reason to be recorded in writing, the Admission Committee suspects that a particular candidate has obtained a certificate by mis-representing facts; the Admission Committee would take the final decision regarding

- admission of the candidate.
10. Document not found confirming to requirement may lead to disqualification.
 11. At the time of counseling, the candidate who is called for allotment of seat must present himself/herself before the committee and if allotted the seat after verification of the documents, he/she must deposit the prescribed University/college fee
 12. The candidate failing to report in the college after admission on stipulated date will not be further entertained and his total amount of fees will be forfeited.
 13. ICAR nominated candidates have to report on the counseling date declared by the University for taking admission to M.V.Sc. and Ph.D. programmes and have to deposit their prescribed fee of the university on counseling date.
 14. All the original certificates and mark sheets must be brought by the candidate at the time of counseling and prescribed fee has to be deposited at the time of allotment of the seat, failing which the admission will be given to the next candidate in the merit.

VERIFICATION OF DOCUMENTS

The candidates must bring compulsorily following original documents for verification on the day of counseling along with one set of self-attested photocopies (both sides of documents):

- i. Domicile certificate of Rajasthan state
- ii. Proof of date of birth
- iii. Computer generated confirmation page of online application submitted to NTA (For ICAR candidates only)
- iv. Computer generated print out of RAJUVAS application form (For all candidates except ICAR candidates)
- v. Admit card of **ICAR-AIEEA (PG) 2024** and **ICAR AICE-JRF/SRF (Ph.D.) 2024** examination (whichever is applicable).
- vi. Copy of Rank card and counseling letter issued by ICAR to eligible candidates.
- vii. Allotment letter issued by the ICAR to eligible candidates
- viii. Provisional admission letter issued by admitting University for ICAR candidates.
- ix. Mark sheet and provisional /degree certificate of B.V.Sc. & A.H. for M.V.Sc. candidates and B.V.Sc. & A.H. and M.V.Sc. mark sheet and degree certificates for Ph.D. admitted candidates (whichever is applicable).
- x. Mark sheet and certificate of Senior Secondary School Examination.
- xi. Mark sheet and certificate of Secondary School Examination.
- xii. Character certificate issued from the College last attended.
- xiii. Caste certificate from the competent authority, if applicable.
- xiv. Aadhar Card or any other valid Govt. Identity proof as applicable
- xv. Physically Handicapped Certificate from competent authority as per provision, if applicable.
- xvi. No Objection Certificate from Employer (Competent authority) for In-service candidates.
- xvii. Four identical colour photographs which should be same as uploaded for online application form.

MEDICAL EXAMINATION

All the candidates provisionally admitted to M.V.Sc./Ph.D. degree programme will have to submit Physical Fitness certificate from Medical Jurist/Medical Officer of Govt. Hospital/Medical College. The admission of candidates found unsuitable in Physical Fitness will be cancelled and in such cases fee will be forfeited.
