Conditions of Supply:-

1. Rates should be quoted for good quality goods showing the various details of specifications.
2. Rates quoted should be F.O.R. Krishi Vigyan Kendra, Chak-27 NTR, Nohar, Hanumangarh and inclusive of all taxes.
3. Supply will have to be made within 10 days from the date of the order.
4. After the tender has been accepted, the rates shall remain valid for the period 31-03-2025. The period can be extended by mutual agreement.
5. No counter proposals or modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the tender is submitted in response to our tender notice, it will be made applicable to acceptance of terms & conditions given by us and no claims will be entertained. In other words, firm intending to give counter proposals should not submit tender at all.
6. Alternative specifications will not be acceptable.
7. Articles should be strictly accordingly to the specifications.
